I have had the good fortune of working with Ward Construction Company (WCC) on three projects since 1992. One of these projects was the renovation of a building for my company's offices. Most recently, we worked together on a renovation/addition project for a Denver Synagogue. Congregation Rodef Shalom.

Their role in the latter, a \$2.3 million project, was as construction manager/general contractor, with involvement from the feasibility study stage through construction. Throughout the course of the project they showed the uncommon commitment to the Owner's interests for which they have a well deserved reputation. Among the complexities of this project was the circumstances of a non-profit client with substantial practical and political requirements. The schedule required that the existing facilities remain in operation during the course of the work, necessitating an incremental construction schedule.
